- **SOLUTIONS FOR A MORE SUSTAINABLE WORLD**
Solutions to control environmental risks and thus contribute to the development of more resilient production and consumption models that respect ecosystems.
 - *For example: Greenhouse gas (GHG) emissions assessment / Carbon assessment; support in obtaining energy saving certificates (CEE); verification of renewable and low-carbon energy production systems; support towards certification, or certification of energy management systems (ISO 50001); waste diagnosis before demolition, technical building control or renovation using bio- and geo-sourced materials; inspection; studies and advice for the operation of establishments classified for environmental protection (ICPEs); Fauna/flora diagnosis; Obtaining biodiversity labels...*

- **SOLUTIONS FOR A SAFER WORLD**
Solutions to improve the health, safety and well-being of employees at work, and to ensure safer and healthier places to live for everyone.
 - *For example: advice on the development of a prevention culture and initiatives related to Quality of Life and Working Conditions (QLWC); safety checks on living spaces (playgrounds, sports facilities, etc.); compliance checks related to building accessibility standards; assessment of indoor or outdoor air quality, etc.*

- **SOLUTIONS FOR SHARED PROGRESS**
Solutions contributing to the development of human capital by promoting the employability of all through training courses leading to qualifications and to the protection of companies and its employees from new risks, in particular digital risks.
 - *For example: training leading to qualifications or certifications (production line operators, electric vehicle charging station installers, heating, ventilation and air-conditioning maintenance technicians (TMCVC), warehousing agent, etc.); apprenticeship training within the Apave apprentice training centres; digital risk prevention (intrusion testing, data protection, cyber security, etc.).*

- **SOLUTIONS FOR A TRUSTED WORLD**
Solutions that contribute to developing transparency and trust between stakeholders and towards consumers, and thus accelerate collaboration among sectors to collectively build a desirable economy.
 - *For example: audits to verify the quality of contracting companies; Extra Financial Performance Audits (EFP); 'Responsible Supplier Relations and Purchasing' certification label; audits for validating/verifying contracting companies; product certifications; qualification of equipment for CE marking....*

This range of solutions is part of the European framework of Green Taxonomy today, and the Social Taxonomy of tomorrow.
