## **AUTHORISATION TO CONDUCT FABRICATION SURVEY OF PRESSURE SYSTEMS (PIPINGS) FOR USE IN SINGAPORE.**

1. Thank you for endorsing the “Conditions for authorisation as an Inspection Agency of Pressure Systems (Pipings)” as an indication of your organisation’s wish to join our Approved Inspection Agency authorisation scheme.

### **Authorisation**

2. Your company is authorised to conduct fabrication surveys of pressure systems (pipings) during construction for the purposes of the Singapore’s Workplace Safety and Health Act. **Please note that this authorisation is granted from 16 July 2024 to 16 July 2029.**
3. Please also note that your office is to abide by the terms of the “Conditions” that they have endorsed. The authorisation may be withdrawn if you are found violating any of the conditions, and as a result, the pressure vessels (pipings) which your Approved Inspectors have surveyed, may not be accepted for registration in Singapore.
4. We reserve the right to terminate this authorisation if you fail to properly review, inspect, or test a system in accordance with the regulations, or if we discover false statements in your application. Failure to maintain an acceptable experience base is also a cause for revoking your authorisation. We also reserve the right to conduct oversight reviews of your surveys and inspections.
5. This authorisation is conditioned upon the continuous maintenance of adequate technical competency and compliance with the quality management control assured us by your quality manual.



## Approved Inspectors

6. You will find attached a list of Approved Inspectors who are authorised to carry out inspection of pressure systems (pipings) in Singapore. Please check through the list of Approved Inspectors and inform us immediately if their names are spelled wrongly.
7. Please note that only Approved Inspectors on the List of Approved Inspectors (enclosed with this letter) may carry out surveys of pressure systems (pipings) on behalf of this Division. Their inspection activities are restricted to the countries where they are approved. You shall notify this Division immediately of any changes in the list of the Approved Inspectors, or if they are no longer in the service of your company. The Approved Inspectors shall also cease to be Approved Inspectors when they reach the age of 65 years old.
8. The Approved Inspectors shall sign all certificates, reports and endorsements etc relating to works carried out for the purpose of this approval. The Approved Inspector shall also stamp these documents with his individual stamp and the organisation's stamp.

## Markings

9. The pressure systems (pipings) surveyed by the Approved Inspector shall bear a unique number that is to be hard-stamped with his stamp. This stamping shall appear on a prominent location on the body of the pipings.
10. Please note that this Division will not approve any pipings to be used in Singapore if the above instruction is not followed, and any certificate or report issued will therefore not be recognised by this Division.

## Expiry and Renewal of Authorisation

11. If, at the end of the authorisation period, you wish to be granted authorisation for a further period, you are requested to write in to reapply for authorisation, at least two months before the expiry of your current authorisation. Your Authorisation will lapse if we do not receive any request for extension of authorisation, and any pressure pipings surveyed after the expiry of your authorisation will not be accepted for registration in Singapore.

## Other Matters

12. Please check through the list of Approved Inspectors enclosed and inform me if there are any errors.
