## Airworthiness oversight for aviation safety

OSAC HABILITATION, a subsidiary of OSAC within the Apave Group, is authorised by ministerial decree to carry out oversight missions for aviation safety and to issue airworthiness documents. OSAC HABILITATION intervenes either as part of the Authority, or by delegation, or as a subcontractor of the Direction Générale de l'Aviation Civile.

#### **Missions**

- Issue and surveillance of approvals regarding aircraft production and maintenance, continuing airworthiness management and maintenance staff training.
- Inspections and checks necessary for the issue of individual airworthiness documents.
- Examine applications and issue aeronautical mechanics licenses.

- Accreditation of staff to carry out aircraft airworthiness reviews.
- Assistance to the French Civil Aviation Safety Directorate (DSAC) in monitoring airworthiness and in publishing airworthiness directives.
- Training and information on aviation regulations.

#### Serving aeronautical organisations

- Aircraft operators,
- Production organisations,
- Maintenance organisations,
- Aeronautical mechanics,
- Aircraft maintenance training organisations,
- Continuing Airworthiness Management Organisations,
- Combined Airworthiness Organisations.

#### Ministerial decree of 2023 December 20<sup>th</sup> relating to OSAC HABILITATION accreditation (extract)

Art. 1 and 2 - OSAC HABILITATION performs expert missions, control and audit activities (...).

- as part of the authority in accordance with the regulations issued for the application of Regulation (UE) No 2018/1139 ;

by delegation of the Minister of Civil Aviation for activities under the national regulations;
as a subcontractor of the civil aviation safety authority, when it acts on behalf of a third party;

- within the framework of international agreements, as part of the authority defined in said agreements.

The competence of OSAC Habilitation's experts and inspectors is continuously maintained through an ambitious training programme as well as skills and knowledge assessments, which are formalised by the **aeronautical inspector's license**.

#### Listening to customers

Oversight is designed primarily for civil aviation professionals and hence it has to be coordinated with them. The **Consultation and Coordination Committee for Aeronautical Technical Control** (GCCCTA) was created with this principle in mind. Meeting quarterly, it brings together OSAC Habilitation with organisations and groups in the domain.
