## PPL Training: a leader in technical training in the UK

PPL Training has been supporting its customers for almost 20 years in training their teams in workplace safety and technical compliance.

Recognised as a leader in its market, PPL Training offers its customers a wide range of training courses: electrical and mechanical safety, water hygiene and sanitation, safety in the healthcare system, gas handling and fire safety.

With over 70 employees, including many qualified trainers, the company has numerous accreditations from UK certification bodies to ensure the quality of its training courses, such as City & Guilds and BPEC (British Plumbing Employers Council).

Here, Apave confirms its commitment to supporting its customers and the general public in making their homes and workplaces safer.
